TERMS & CONDITIONS

- Service includes 1 press release per year. Additional releases are available for an added fee.
- Distribution timing will be scheduled by the LibDib PR team based on our editorial calendar and on a first-come, first-served basis.
- Press release topics must be relevant to LibDib distribution or major brand milestones (e.g., new markets, awards).
- Makers must provide key product details, brand background, and images to support development. [Click here for the submission form.]
- LibDib PR will distribute the release to targeted wine and spirits trade media. While media pickup is not guaranteed, we'll do our best to maximize exposure.
- A one-time coverage summary will be shared with the Maker after distribution.
- Only available to Gold Makers in good standing.
- Makers must be part of the Gold Program for at least 6 months to participate in the PR program. If a press release is distributed before the 6-month mark, the Maker agrees to remain in the program for a minimum of 6 months total.

ADDITIONAL BUSINESS WIRE ADD ON

<u>Business Wire</u> distribution is available for an additional fee. If chosen as an add-on, LibDib will distribute the release via their Business Wire account (discounted rate) and will bill the fee back to the Maker.

- \$100 wire and reporting set up fee (to cover LibDib's time for setting up the distribution and providing a pick up report)
- The ability to choose from several distribution options. LibDib's special pricing agreement with Business Wire includes:
 - **SF Bay Area Circuit** For each non-earnings release of unlimited words issued to the SF Bay Area Circuit, Client will receive a flat rate of \$370 USD.
 - Southwest circuit, Pacific Coast Circuit, or the NY State Circuit For each non-earnings release of unlimited word count issued to the
